

NEW HANOVER TOWNSHIP

ORDINANCE NO. 2018-09

AN ORDINANCE OF THE TOWNSHIP OF NEW HANOVER,  
IN THE COUNTY OF BURLINGTON, NEW JERSEY,  
PROVIDING FOR THE REPLACEMENT OF NECESSARY  
AND REQUIRED FIREFIGHTING AND PROTECTIVE  
EQUIPMENT FOR THE TOWNSHIP AND APPROPRIATING  
\$45,000 TO FUND THE SAME.

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF  
NEW HANOVER, IN THE COUNTY OF BURLINGTON, STATE OF NEW JERSEY,  
(not less than two-thirds of all members thereof affirmatively  
concurring) AS FOLLOWS:

**Section I.** For the purpose of the replacement of  
necessary firefighting and protective equipment used by the  
Township's Firefighting Department, and all work and related  
materials necessary therefore and incidental thereto, there is  
hereby appropriated the sum of \$45,000 from the Township's  
Capital Improvement Fund

**Section II.** The capital budget or temporary capital  
budget (as applicable) of the Township is hereby amended to  
conform with the provisions of this ordinance to the extent of  
any inconsistency herewith. In the event of any such  
inconsistency and amendment, the resolution in the form  
promulgated by the Local Finance Board showing full detail of  
the amended capital budget or amended temporary capital budget  
(as applicable) and capital program as approved by the Director

of the Division of Local Government Services is on file with the Clerk and is available there for public inspection.

**Section III.** All ordinances or parts of ordinances inconsistent herewith are repealed.

**Section IV.** This ordinance shall take effect after second reading and publication as required by law.
