RESOLUTION NO. 2018-102

**RESOLUTION TO AWARD A CONTRACT FOR THE
REPLACEMENT OF THE FLAT ROOF OF
THE MUNICIPAL BUILDING**

WHEREAS, the Township of New Hanover (the 'Township') is in need of the repair and/or replacement of the existing flat roof sections of the Municipal Building located at 2 Hockamick Road, and

WHEREAS, the Township Engineer has inspected the roof and opined that the roof requires immediate and emergent replacement due to, among other factors, the inability of the roof to protect the building from moisture intrusion for various reasons and the interior moisture damage already realized by the condition of the roof. It is necessary to invoke N.J.S.A. 40A1-6 (emergency purchases and contracts in order to obtain the immediate delivery of the materials, supplies or the performancy of the services; and


WHEREAS, the Township Engineer has solicited quotations for the Replacement of the Flat Roof of the existing Municipal Building and received two (2) quotes of the four (4) quotes requested. It is requested that a purchase order be issued without public advertisement for bids, pursuant to the above cited statute; and

WHEREAS, the lowest responsible quoter was Gary F. Garner, Inc. in the amount of \$51,119.78; and



WHEREAS, the Township Engineer has reviewed the submitted quotes and recommended award of the contract to Gary F. Garner, Inc. in the amount of \$51,119.78 via correspondence dated November 6, 2018, subject to the conditions contained therein,

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of New Hanover that the project known as the Municipal Building Flat Roof Replacement Project, is awarded to Gary F. Garner, Inc. in the amount of \$51,119.78, subject to submission of required documentation.
