RESOLUTION AWARDING CONTRACT FOR COLLECTION AND DISPOSAL OF SOLID WASTE TO WASTE MANAGEMENT OF NEW JERSEY, INC.

WHEREAS, the Township of New Hanover (hereinafter "the Township") is authorized pursuant to N.J.S.A. 40A:11-1 et seq. (the "Local Public Contracts Law") to award contracts for the purchase of goods and services to the lowest responsible bidder, in accordance with the results of an open and competitive bidding process;

WHEREAS, the Township publicly advertised for the receipt of bids for a contract to provide for the collection and disposal of municipal solid waste, which the Township received on March 5, 2020.

WHEREAS, three potential bidders requested specification, one (1) bid proposal was received; and

WHEREAS, the proposal of Waste Management of New Jersey, Inc. ("Waste Management") has been reviewed by the Township Attorney, CFO and Administrator, and has been determined to be responsive and responsible, and

WHEREAS, Waste Management's proposal for a five (5) year contract is as follows:

Year 1:	\$69,960 for	base	services	plus	\$22.00	per	month	for	each

Year 5: \$81,840 for base services plus \$26.00 per month for each additional housing unit.

WHEREAS, the Township staff recommends that the Township award a five (5) year contract commencing April 1, 2020 and expiring on March 31, 2025 to Waste Management of New Jersey, Inc. for the collection and disposal of solid waste.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of New Hanover, County of Burlington, State of New Jersey, that:

- 1. A contract for the collection and disposal of solid waste is hereby awarded to Waste Management of New Jersey, Inc. for a term of five (5) years commencing on April 1, 2020 and expiring on March 31, 2025, in an amount not to exceed \$378,912.
- 2. The continuation of the contract for the second and subsequent years is conditioned upon the availability and appropriation of funding by the Township Committee of the Township of New Hanover in each subsequent lawfully adopted budget.
- 3. The Township Mayor and Clerk are authorized to execute a contract with Waste Management of New Jersey, Inc. for the collection and disposal of solid waste consistent with this Resolution.
