

**NEW HANOVER TOWNSHIP
ORDINANCE NO. 2020-04**

**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 164 ARTICLE V SECTION 164-38
SCHEDULE XVI: SPEED LIMITS OF THE NEW HANOVER TOWNSHIP CODE**

WHEREAS, the Township Engineer, Joseph Hirsh, PE, CME, CPWM, has recommended that the speed limit on Bunting Bridge Road be changed to 25 mph from Main Street to 3,650 feet east of Main Street and 35 mph from 3,650 feet east of Main Street to the Township Line, in the interest of safety of the residents; and

WHEREAS, the Township Committee of the Township on New Hanover believes that such a change is in the best interest of the residents of the Township for the New Hanover Township; and

BE IT ORDAINED by the Township Committee of the Township of New Hanover in the County of Burlington, State of New Jersey, as follows:

Section I: Chapter 164 Article V Section 164-38 of the Codified Code of the Township of New Hanover is hereby amended as follows:

Name of Street	Speed (mph)	Location
Bunting Bridge Road Zone 1	25	Between Main Street and 3,650 feet east of Main Street
Zone 2	35	Between 3,650 feet east of main street and the easterly New Hanover Township line

Section II: Severability. If the provisions of any section, subsection, paragraph, or clause of this Ordinance shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, or clause of this Ordinance.

Section III: Repealer. This Ordinance is only intended to address the speed limit on Bunting Bridge Road. All portions of Chapter 164 Article V Section 164-38 which address the speed limit on other road shall be unaffected by this Ordinance. All ordinances or parts of ordinances inconsistent with this Ordinance are hereby repealed to the extent of such inconsistency.


Section IV: Effective Date. This Ordinance shall take effect upon final passage and publication as provided by law.
